## ■ NYDIS's Open Letter on Immigration Reform

In an Open Letter to the New Yorkers and the public on NYDIS's website, Executive Director Peter Gudaitis urges religious leaders and congregations to advocate for humane and comprehensive reform of immigration laws. Undocumented workers from Ground Zero represent over 40% of our client base at the Unmet Needs Roundtable. "It is up to you and up to all of us to ensure the nation we love survives the politics of fear, blame and blind reaction. Communities of faith are well represented in the debate on comprehensive immigration reform, which directly affects so many of our friends, families and neighbors" as well as our NYDIS clients.

NYDIS encourages its members and partners to oppose legislation which criminalizes undocumented immigrants and those who assist them. That would include us all - the faith-based disaster providers, social workers, houses of worship and their religious leaders. Our elected leaders need to know how we feel about this issue in order to ensure the passage of a progressive and compassionate reform bill.

## ■ NYDIS Invited to Trinity's Post-Disaster Roundtable in DC

Executive Director Peter Gudaitis has been invited to speak at a roundtable discussion exploring the interaction between the public and private sectors, the challenges of disaster relief, and the relevant lessons that can be applied to future response efforts. "Reflecting on Katrina, Rita and 9/11" is presented by The Trinity National Leadership Roundtable on Tuesday, May 23 in Washington, D.C. The forum will delve into the role of churches, non-profits, governments and business in disaster relief. The forum has met regularly since the 1970s for Episcopal leaders to discuss issues pertaining to worldwide outreach.

The facilitators are Walter Isaacson, President and CEO of The Aspen Institute and Vice-Chair of the Louisiana Recovery Authority and Carl Weisbrod, President of the Real Estate Division of Trinity Church Wall Street and member of the LMDC and a trustee of the Ford Foundation.

### • **Katrina Evacuee Study Finds Declining Health**

In the April 18th issue of the NY Times, Shaila Dewan reported that a study conducted by the Mailman School of Public Health at Columbia University and the Children's Health Fund, found that families displaced by Katrina are suffering from mental disorders and chronic conditions like asthma and from a lack of prescription medication and health insurance at very high rates.



Among the findings, 34% of displaced children suffer from conditions like asthma, anxiety and behavioral problems and 14% went without prescribed medication at some point; and 44% of their parents and guardians had no health insurance. The study recommends expanding Medicaid to provide universal disaster relief and emergency mental health services, and sending doctors and counselors from the federal Public Health Service to the region.

- **New Orleans Election Results & Resources**

On Saturday April 22, New Orleans held its first mayoral election since Hurricane Katrina. Despite that less than half the residents have returned to New Orleans, 80% who voted in 2002 voted in Saturday's election with the gap largely made up of displaced black residents. Many displaced residents traveled from neighboring states to cast their ballots. Turn-out was 36% for this election compared to the 2002 mayoral election of 46%. White voter turn-out is usually higher than black, but according to analysts the gap was about double the normal for this election, with about 20,000 absentee ballots received. A run-off election is scheduled for May 20 between the incumbent C. Ray Nagin who received 38% of the vote, and Lt. Governor Mitch Landrieu who captured 29%. Ron Forman, a nonprofit executive, came in 3rd with 17% of the vote.

New Yorkers for the Gulf Coast is running a media campaign designed to heighten absentee voter participation among displaced Louisiana residents currently in the NY area. For more information on voting in the run-off election by absentee ballot see the resources below:

- **Lawmakers Call for 9/11 Responders Benefits**

After an autopsy of retired NYPD Detective James Zagroda revealed that

his death was a direct result of his toiling at ground zero, NY's elected officials are calling for full pension benefits for the families of 9/11 responders who worked there. The NY Daily News reported last week that Senator Chuck Schumer recommends "...to change the pension rules to reflect this sad reality," and Rep. Carolyn Maloney is looking into securing federal aid, "...if they died because of 9/11, their families deserve to be fully compensated."

- **NYPD Urges: If You See Something, Say Something!**

NYPD SHIELD is a program that offers private sector security managers (including security directors of houses of worship) a way to obtain information and engage Police resources. It provides a wide range of training to assist public and private sector entities in defending against terrorism, keeps them informed of developing situations and special event preparations in the city, and new intelligence and threat information. It is notable in that this initiative advocates a two-way street - information flowing in both directions. During counterterrorism deployments especially, the knowledge held by the public of buildings, blocks and neighborhoods, knowing what belongs and what is out of place, is crucial.

Dr. Isaac Weisfuse, deputy commissioner of disease control in NYC's Department of Health and Mental Hygiene, suggests people practice what he calls "respiratory etiquette." He advises, "...cover your cough, cover your sneezes, wash your hands. Although those sound like old-fashioned things, they are actually important in terms of interrupting transmission of a respiratory agent like flu."
