■ NYDIS Board Approves \$2.6M 2007 Budget

On Thursday, October 26, NYDIS held its 2007 Annual Meeting at NYU's Kimmell Center. Following the election of a new slate of officers for 2007, the Board of Directors approved a \$2.6 million annual budget. The budget represents a 10% increase over 2006.

■ NYDIS ED Invited to DHS Review of NRP & NIMS

NYDIS was invited by Secretary Chertoff to be one of 70 agencies from across the US to participate in the review and revision of the National Response Plan (NRP) and the National Incident Management System (NIMS). On October 25, Peter Gudaitis participated in the Department of Homeland Security's (DHS) all-day stakeholder kick-off meeting to review and revise the NRP and NIMS held in Washington, DC. The NRP review will examine the plan's policies, coordinating structures, defined areas of responsibility and procedures. An upgraded NIMS document will also be developed - both for release in FY 2007.

■ NYDIS & NYCOSH Publicize Worker Comp Deadline

NYDIS is joining the NY Committee for Occupational Safety and Health (NYCOSH) in collaboration with the NYS AFL-CIO, WTC Medical Monitoring Program, the Laborers' Health and Safety Trust Fund, the Business and Labor Coalition of New York, workers' compensation law firms, the UCC-National Disaster Ministries, and Wall Street Rising, is mounting a media campaign to inform workers throughout the country about the necessity of registering for workers' compensation. Joel Shufro, NYCOSH Executive Director, said, "We know that tens of thousands of people are at risk of becoming ill as a result of their exposure toxic air and to psychological trauma while doing rescue, recovery or



cleanup work after 9/11. We want to ensure that every one of them registers with the Workers' Compensation Board before the August 14, 2007, deadline. And if they don't know about the program, they won't register, it's that simple."

In May, NYDIS was awarded funding through 2006 to staff and host the NYC Katrina Unmet Needs Roundtable. Case managers working with Katrina or Rita survivors are required to attend an in-service training prior to presenting at the Roundtable. The purpose of these trainings is to provide case managers with a better understanding of the workings of the Roundtable and to help increase the likelihood that a client's needs could be funded.

■ **Human Remains Search Begins Again at WTC Site**

On October 20, Deputy Mayor for Administration Edward Skyler, who is overseeing the new recovery effort, released a statement regarding the remains that were found at Ground Zero. "...I convened a 90-minute meeting with a group of City and State agencies, the Port Authority, and private utilities to respond to yesterday's discovery of human remains at the WTC site...several steps will be taken immediately. Con Ed and Verizon will inspect several other manholes and underground areas near West Street, and remove any material that may be found. The City's Medical Examiner will carefully sort all material recovered to identify any human remains. The Medical Examiner's forensic anthropologists will work closely with Police and Fire personnel, who will be on scene at all times. If any remains are found, they will be taken to the Medical Examiner's facility, as was the case with other victims of the 9/11 attacks."



Mayor Michael Bloomberg said on October 23 that "there was a lot of pressure to do things quickly," but said workers "did everything they thought was appropriate at the time, as much as they could. It was just a massive task where things are spread out for a very large area, and the practical reality is you can't get to everything."

The terror attacks killed 2,749. The remains of 1,150 victims have not been identified.

■ **Mayor Orders Expanded WTC Search for Remains**

On October 27, Mayor Bloomberg accepted recommendations contained in a report from the Department of Design and Construction (DDC) Commissioner David J. Burney and Lower Manhattan Construction Command Center (LMCCC) Executive Director Charles J. Maikish which recommended expanding the



current search for human remains at and near the WTC site - underground, on rooftops and in buildings.

■ DOT Sent to Help Cleanup Western NYS Snowstorms

Governor Pataki, on October 22 announced that an additional 303 NYS Department of Transportation (DOT) highway maintenance workers were deployed to aid in ongoing recovery operations, joining the more than 800 DOT, National Guard, State Police, and other State agencies personnel already there. Governor Pataki said, "As the residents of Western NY continue to recover from the devastating effects of the October 12-13 record snowfall, we are stepping up the level of assistance we can provide to hard hit areas..." The NYS Emergency Management Office (SEMO) is urging all residents to exercise caution when traveling on local roads and to be attentive to local emergency orders.

■ Storm Shifts NYSEG Focus to Preventative Measures

Service has now been restored to 98% of NYS Electric and Gas' (NYSEG) customers who lost service as a result of the Western NY snowstorm that severely damaged the company's delivery system. NYSEG is now turning its attention to ways to prevent future problems. Follow-up work includes a final helicopter patrol, the inspection of transformers, power lines and other equipment using infrared scanners, a detailed visual inspection, and making permanent repairs where temporary repairs have already been made.

■ Power Grids' Assessment Report Calls for Action

The North American Electric Reliability Council (NERC), assigned by the federal government to ensure that the electric system in North America is reliable, adequate and secure, released their 2006 Long-Term Reliability Assessment Report. It determined that companies are not building power plants and power lines fast enough to meet growing demand, and that the amount of power that could be generated would drop below the target levels on peak days in Texas, New England, the Mid-Atlantic area and the Midwest.

■ **FAA Changes East River Rules for Small Aircraft**

As a result of the UES plane crash that killed Yankee pitcher, Cory Lidle, and his flight instructor in NYC on October 11, the Federal Aviation Administration (FAA) announced it would prohibit private aircraft from the low-altitude East River corridor in most cases, effective immediately. The ban will remain in place indefinitely and those planes that are allowed to fly along the East River must maintain contact with air traffic control. NY politicians were alarmed that planes could still get close enough to NY's skyscrapers and other landmarks since 9/11.

■ **Report Card for Major Cities' Evacuation Abilities**

The American Highway Users Alliance has released a first-of-its-kind study evaluating the emergency evacuation capacity of the 37 largest US urban areas with at least 1,000,000 populations. Ten received grades of "B" or "C," six got a "D," and 20 got an "F"; only Kansas City, MO, got an "A." The report, "Emergency Evacuation Report Card 2006: 25 Urban Areas Could Face Greater Challenges than New Orleans Experienced after Hurricane Katrina", calls for expanded roadway capacity and automobile access, the establishment of a national urban evacuation standards and reporting system, and for the completion of urban area evacuation plans. "The potential for terrorist attacks and last year's New Orleans flood destruction underscore the necessity for providing sufficient evacuation capacity from the nation's urban areas," according to the Alliance.



NY was one of the 20 lowest-scoring areas, receiving an "F".

Authorities face even greater challenges in the NY area due to the unusually high number of mass transit dependent households. The principal resources of evacuation for the mass transit dependent are buses, with a supplemental role of commuter rail, Amtrak and, to a lesser extent, subway systems. Based on the experiences in NO and Houston, people without cars must depend on government to provide necessary evacuation transportation programs and improvements are necessary.

■ US Anti-Terror Law Concerns Red Cross

The Geneva-based International Committee of the Red Cross is expressing its "concerns and questions" over whether a new US anti-terror law signed by President Bush complies with the Geneva Conventions on the conduct of war. The legislation, signed into law on October 17, authorizes military trials of terrorism suspects, eliminating some of the rights defendants usually are guaranteed under US law, while allowing continued harsh interrogations of terror suspects. Jakob Kellenberger, president of the Red Cross said his concerns include "the prohibition of the denial of the right to a fair trial, which is a basic protection provided for in international law."

■ Re-Building NO Takes a Unified Effort

The Unified New Orleans Plan (UNOP) is the single, comprehensive recovery and rebuilding plan for Post-Katrina New Orleans, and will be implemented under the auspices of the NO Community Support Foundation. Major funders are The Rockefeller Foundation and the Greater NO Foundation. There is a series of 4 district-level meetings and 3 city-wide meetings being held this Fall.



Efforts are being made to videotape these meetings so that they can be viewed online and to establish resource centers at public libraries where displaced residents can view the videos and additional materials.

The next meetings are:

District Meeting 2: Nov 11 (Scenarios)

Community Congress 2: Dec 2 (Citywide recovery scenarios; this will occur simultaneously in 5-6 cities)

District Meeting 3: Dec 16-17 (Review draft district plans)

District Meeting 4: Jan 6-7 (Final district plans)

Community Congress 3: Jan 13 (Complete draft recovery plan)

■ **Federal Court Rejects City's Immunity at Ground Zero**

A federal judge has rejected the city's claim that it is protected by law from being sued over the way it handled rescue and recovery operations at Ground Zero. The ruling opens the way for lawsuits by thousands of workers who say they were made sick by exposure to toxic substances during the 10-month cleanup. Judge Alvin K. Hellerstein of US District Court in Manhattan rejected the city's motion to dismiss the lawsuits. In a 99-page decision released October 17, he stated that state and federal statutes do provide some immunity for the city, its private contractors and the Port Authority of NY/NJ for actions undertaken in response to an enemy attack. However, he said that protection is not universal and varies by time and place, making it necessary to hear the details of individual cases. "If even a minority of plaintiffs suffered serious injuries to their respiratory tracts arising from the acrid air of Sept. 11, their claims deserve to be heard when a recovery could make a difference to their lives," Judge Hellerstein wrote. The judge ordered a conference to be held on November 3 to consider the appointment of a special master and other issues.

- **NYBR Hires Pastoral Counselor for Gulf Coast**

New Rabbinic Pastoral Counselor for Hurricane Katrina Support, Rabbi Dr. Myrna Matsa will work closely with the rabbis and cantors of New Orleans, Baton Rouge and Mississippi in their work during this period of reconstruction post-Katrina. Rabbi Stephen Roberts, Associate Executive VP of the NYBR said, "I have been working hard within the Jewish community, in particular with UJC, to have them provide long term disaster pastoral support for faith leaders directly impacted by Hurricane Katrina. Hopefully we can get other faith communities to follow suit with similar positions. This is an important model to help sustain communities and their faith leaders after significant disasters." This two-year position is funded by a major grant of United Jewish Communities–UJC Emergency Committee, and will be based out of Biloxi/Gulfport, Mississippi beginning November 1.

- **Faith-Based Help for NYS Snowstorm Residents**

Faith-based and voluntary organizations are not only helping Western NYS residents with their recovery, but they also are tallying damages that may lead to federal individual assistance grants. In the wake of several feet of snow, hundreds of residents faced extended power outages, basement flooding, trees that fell on roofs, and several feet of floodwater inside of homes. The expense of repairing these damages may range from \$500 to \$2,000, an "expense many families simply can't swing," said Church World Service (CWS) Disaster Response and Recovery Liaison Joann Hale. Faith-based groups helping in the effort include CWS, The Salvation Army, the Southern Baptists and the United Methodist Committee on Relief (UMCOR); and they are meeting next week to continue discussing a coordinated response and the possibility of bringing in volunteer teams from outside the area, reported Hale.

- **Most Hurricane Vulnerable Cities – LI on List**

The International Hurricane Research Center at Florida International University released its report on the "10 Most Hurricane Vulnerable Areas", with New Orleans topping the list. The criteria used included storm frequency and intensity, flooding potential, erosion trends, population, and evacuation routes. The second city listed was Lake Okeechobee, FL, followed by: Florida Keys, Coastal Mississippi, Miami/Ft. Lauderdale, FL, Galveston/Houston, TX, Cape Hatteras, NC, Eastern LI, NY, Wilmington, NC, and lastly, Tampa/St. Petersburg, FL. Dr. Stephen Leatherman, IHRC Director warns that given the historical record, the East End of LI, NY is "overdue" for a major hurricane, pointing to the fragile sandy barriers on the island's south shore.

- **WHO Releases Pandemic Flu Vaccine Action Plan**

The World Health Organization's (WHO) new Global Pandemic Influenza Action Plan to Increase Vaccine Supply addresses the



potential large vaccine shortage of several billion doses. The plan calls for an increase in seasonal influenza vaccine use and vaccine production capacity, as well as further research and development to design more potent and effective vaccines. In a statement on October 23, Dr Marie-Paule Kieny, Director, WHO Initiative for Vaccine Research, said, "The Global Action Plan sets the course for what needs to be done, starting now, to increase vaccine production capacity and close the gap. In just three to five years we could begin to see results that could save many lives in case of a pandemic."

- **CDC Awards \$5.2M to Evaluate Flu Impact**

The Centers for Disease Control and Prevention (CDC) announced \$5.2 million in new cooperative agreements to evaluate the effectiveness of community-level measures that could be used during an influenza pandemic to reduce the spread of infection. Because developing a vaccine against a pandemic influenza strain could take several months, community prevention strategies that don't involve vaccines or other drugs (also called "non-pharmaceutical interventions") may serve as a first line of defense.

- **Pandemic Prospect Complicates Emergency Planning**

The possible pandemic outbreak of a contagious disease could render many emergency management and continuity-of-operations plans moot, according to a panel of experts at the CIO Forum and Executive IT Summit in Falls Church, VA, reports Federal Computer Week (FCW). The panelists said plans designed to deal with a bombing or a hurricane wouldn't necessarily apply to an outbreak of avian flu because, as Steve Cooper, former CIO at the Homeland Security Department and now CIO at ARC, said, "the Red Cross' normal procedure is to establish service centers near a disaster area. But that wouldn't work in a pandemic. Nobody is going to show up at our service centers, in that case, that model gets turned on its head." The panel agreed that they have time to develop plans that consider a pandemic, but they also agreed they need to work urgently to have them in place and tested before they are needed.
