NYDIS is joining the NY Committee for Occupational Safety and Health (NYCOSH) in collaboration with the NYS AFL-CIO, WTC Medical Monitoring Program, the Laborers' Health and Safety Trust Fund, the Business and Labor Coalition of NY, workers' compensation law firms, the UCC-National Disaster Ministries, and Wall Street Rising, is mounting a media campaign to inform workers throughout the country about the necessity of registering for workers' compensation. Joel Shufro, NYCOSH Executive Director, said, "We know that tens of thousands of people are at risk of becoming ill as a result of their exposure to toxic air and to psychological trauma while doing rescue, recovery or cleanup work after 9/11. We want to ensure that every one of them registers with the Workers' Compensation Board before the August 14, 2007, deadline. And if they don't know about the program, they won't register, it's that simple."

■ NYDIS ED & HSC Mental Health Leaders in New Orleans

On November 6 and 7, Peter Gudaitis joined 16 leaders from the Human Service Council (HSC) on a consultation trip to New Orleans for meetings at the Institute for Mental Hygiene. The HSC team toured devastated areas of the City and met for two days with 20 government and NGO mental health agency executives to discuss recovery best practices and long-term mental health care strategies for New Orleans. Through a grant from the Black Equity Alliance, these leaders will now begin an advocacy and program development partnership to address mental health needs in storm recovery.

■ NYDIS Addresses Brooklyn's African American Clergy

On Friday, November 3, Autumn Brown, NYDIS' Community Outreach and Training Coordinator, attended the regularly called meeting of the Brooklyn Coalition of African-American Clergy and Elected Officials, a Brooklyn-based organization which exists to strengthen and empower the parishioners and constituents of Brooklyn through advocacy and participation in areas of social and economic injustice. With over 40 clergy and elected officials in attendance, NYDIS presented partnership information and an overview of our programs and services.

■ NYDIS/LMCC Attends WTC Memorial Meeting

On October 30 eight representatives from the Lower Manhattan Clergy Council met with staff from the WTC Memorial Foundation Memorial Museum, who presented the latest version of site plans for the Memorial quadrant, including a virtual tour of the visitor's path through the Museum. Topics included recognition of the site as a burial ground, recognition and accommodation of requests for above ground placement of the names of the deceased, as well as plans for the placement of remains within the Museum and for ceremonial transfer of remains now held at the Medical Examiner's Office. Also discussed was the importance of creating a welcoming environment within the Museum for religious visitors of all faiths and identifying locations where groups could gather for religious ceremonies and reflection. Future topics of discussion will include: planning for the return of remains and objects, discussion of exhibit planning and planning related to accommodating people of all faiths in the area where remains will be kept.

■ **HHS Completes Allocation of \$75M for WTC Medical Care**

The US Department of Health and Human Services (HHS) announced on October 27 the completion of the allocation of \$75 million in federal funds for monitoring, screening, analysis and medical treatment of emergency responders and recovery workers at the WTC disaster site. These recent awards build on more than \$125 million that the HHS has administered since 2002. HHS Secretary Mike Leavitt said, "Continued screening and monitoring will promote further scientific understanding of the nature of WTC health effects and will inform our work going forward." This announcement highlights the granting of \$40 million to the Fire Department of NY, LI Occupational and Environmental Health Center, Mt. Sinai School of Medicine, CUNY's Queens College, Bellevue Hospital/NYU School of Medicine and University of Medicine and Dentistry of NJ's Robert Wood Johnson Medical School. The goal of these funds is to assist workers with everything from medications to specialized diagnostic care and treatment.

■ **More WTC Areas To Be Searched For Human Remains**

On November 6, the NY Post reported that an expanded effort to recover human remains around the WTC site is expected to begin after officials identified more than 300 additional spots to search, including manholes, sewers and utility lines belonging to Con Ed and Verizon. The boundaries will be Murray St. to the north, Rector St. to the south, Broadway to the east, and the Hudson River to the west. The searches will be conducted from midnight to 8:00 am.

■ **NYC to Hire More Searchers for WTC Remains**

The renewed search for human remains at the WTC site is so massive, the city plans to hire up to 10 additional forensics experts, a project that



could stretch well into next year, Deputy Mayor Ed Skyler said on November 1. "We will make sure we have the appropriate resources to do this job," said Skyler, who is overseeing the recovery. "The mayor's orders were very clear: 'Do what needs to be done.'" Meanwhile, the Families of September 11 rallied at Ground Zero on November 2, calling for federal intervention, a greater expansion of the remains search and a more clearly defined organization of the effort. Some 200 pieces of bone and other remains have been found so far.

■ **Strong Bond Between 9/11 Families and NYC's ME**

Upon the recent discoveries of more human remains found at Ground Zero, Keith Olberman, host of MSNBC-TV's "Countdown", recently re-aired a special edition program from September 11, 2003, where he interviewed Dr. Robert Shaler of the NY Medical Examiner's Office. They discussed how in this awful process, the ME's office and the victim's families had developed a remarkable bond. As Olberman said, "The families and the scientists have become interconnected in a way no one could have imagined. By some perverse fate, this building, better known as the city morgue, has become a sacred place for many of the loved ones." Shaler responded, "There's concern about our emotions and our well being as we are for theirs, and so it's become a very close working relationship, almost a family type of relationship."

To date, 30,000 responders have been screened under the Program, which is open to responders in NY and across the country who served at Ground Zero. What doctors learn from monitoring the health of thousands of these workers will help future disaster relief workers.

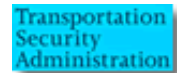

■ **Background Checks May Help 9/11 Families with Lawsuits**

Dozens of 9/11 family members have been striving to get access to information on the attacks. The Transportation Security Administration (TSA) announced on November 1 that it intends to do criminal background checks on plaintiffs who have filed suit in federal court to determine if they can have access to restricted aviation information. This move may help family members move forward in litigation against the airlines that carried victims of the attacks, the airports where the attacks originated, air carriers responsible for security at airport gates, security contractors that performed security screening, and Boeing, which made the planes that were attacked. The family members charge that TSA has not divulged materials that may pose no threat, including many documents once openly available.

■ **Interfaith Recovery Group Helps NY Snowstorm Survivors**

A new long-term recovery organization has been created in western NY to help people in the wake of last month's snowstorm and flooding. The NY nonprofit, Disaster Recovery Interfaith Network of Western New York, will coordinate interfaith response for long-term recovery, provide spiritual and emotional resources for storm survivors and access to individual assistance to those whose needs are not met by federal or state aid. For now, the group is trying to identify unmet needs in the wake of the extended power outage and flooding. They have also distributed flyers to houses of worship in the area informing people about the new group, and encouraging people to look within their membership and their community for unmet needs. Organized under the incorporation of the Network of Religious Communities.

■ **GSA Opens Emergency Response Office**

Emergency workers who need General Services Administration (GSA) services in fast-moving disasters have a new resource. GSA has consolidated its emergency procurement services into a new Office of Emergency Response and Recovery (OERR), putting all of GSA's emergency resources into one central office for first responders, emergency workers and recovery teams. OERR is divided into these divisions: Policy and Plans, Training and Exercise, Disaster Support, and Communications and Security. GSA Chief of Staff John Phelps will be acting chief emergency response and recovery officer until GSA finds a permanent head for OERR. Phelps' disaster response experience includes serving as chief operating officer for the Arizona Red Cross and as deputy director of the Arizona Office of Homeland Security. "We have further refined our capabilities so we can do our job, helping government agencies help the American people during disasters, when they count on us most," said Mr. Phelps.

■ **BENS: Retailers' Role in Disaster Planning**

The US Chamber of Commerce is working with businesses and the Department of Homeland Security (DHS) to create a formal structure in which government leaders and large private sector entities can work together on disaster preparedness and response. Business Executives for National Security (BENS) is a national partnership of over 500 business executives committed to improve the nation's security, in which companies pledge trucks, warehouses and other resources before a disaster, based on needs pre-identified by state officials. Businesses can be quite helpful to governments during disasters: Wal-Mart sent 1,900 truckloads of water and other supplies to the Gulf Coast immediately after Hurricane Katrina; Johnson Controls shipped recreational vehicles to the Gulf Coast to provide their employees with temporary housing; and Home Depot contributed more than \$81 million in reconstruction funds. Systems such as Wal-Mart's, used regularly for supply chain management, can be useful in managing the logistics of delivering supplies from a stockpile to a disaster area.

■ **Academic Recommends Digital Emergency Communications**

Carnegie Mellon University engineering and public policy professor, Jon Peha, at a forum sponsored by the New America Foundation on October 26, called for the development of a government-run communications network that would enable police, firefighters and other emergency responders from different jurisdictions to talk to each other. After the communications failures on 9/11 and during Hurricane Katrina, a mandatory transition of TV to digital signals will open a door for change in public safety communications. Peha said local governments have the primary responsibility for public safety communications, which has led to the current patchwork quilt of systems and standards that make intercommunication difficult.

■ **Though Unprepared Churches Filled Vital Role in Katrina**

Baton Rouge churches, even though they were unprepared, successfully helped thousands of people in the wake of Hurricane Katrina, according to a Louisiana State University (LSU) Public Policy Research Laboratory study, "Tangible and Spiritual Relief after the Storm: The Religious Community's Response to Katrina". The role of disaster relief wasn't new for these congregations, but according to Dr. Daphne Cain, the study's primary investigator and an assistant



professor of social work at LSU, "the churches here in the Baton Rouge area were called upon at a volume that was very different than anything they've ever experienced before." Churches held two keys to successful disaster relief: a lack of red tape and a ready source of volunteers. Observes Cain, "in the event of future disasters, churches across the nation will have the benefit of learning from Baton Rouge's experiences."

Thirteen architects in training at Parsons the New School for Design volunteered for six weeks in hurricane-ravaged Mississippi to conceive and build a combination Information Center and Laundromat. Named the InfoWash, it has just opened in DeLisle, a small town on the Gulf Coast devastated by Katrina's storm surge. The Information Center is now providing people in the area with material about how to apply for government grants, and local people are flocking to the Laundromat.

■ Re-Building NO Takes a United Effort

The Unified New Orleans Plan (UNOP) is the single, comprehensive recovery and rebuilding plan for Post-Katrina New Orleans, and will be implemented under the auspices of the NO Community Support Foundation. Major funders are The Rockefeller Foundation and the Greater NO Foundation. There is a series of 4 district-level meetings and 3 city-wide meetings being held this Fall. Efforts are being made to videotape these meetings so that they can be viewed online and to establish resource centers at public libraries where displaced residents can view the videos and additional materials.

- **Chadbourne Honored for Work with Katrina Victims**

Chadbourne & Parke attorney Laila Hlass received an award on October 19 from Equal Justice Works on behalf of the Student Hurricane Network (SHN). She co-founded SHN, which works with law students and administrators to create and coordinate volunteer legal opportunities in Gulf Coast communities damaged by Hurricane Katrina. Equal Justice Works, founded by law students seeking equal justice for underserved communities, presented SHN with the LexisNexis Martindale-Hubbell Exemplary Public Service Award at its 2006 Awards Dinner in Washington, DC. A native of storm-damaged Long Beach, Mississippi, Laila said, "We have sent over 1,000 students to the region to volunteer during their winter and spring breaks. We have more trips planned." The Chadbourne & Parke LLP Foundation has donated \$110,200 to Katrina relief efforts, which included \$60,200 to NYDIS to help purchase clothes and school supplies for evacuees living in NY. - **FEMA Offers System to Track Disaster Relief Donations**

Hours after Hurricane Katrina struck, the Aidmatrix Foundation began setting up temporary IT systems to mobilize, warehouse, track and distribute private donations of food and other goods and services. The Department of Homeland Security (DHS) is interested in setting up similar donation clearinghouse IT capabilities that can interact with federal agencies and private donations systems. Aidmatrix can manage offers and arrivals of disaster material donations, offers of disaster spontaneous volunteers, offers of disaster financial contributions and material inventory and movement. FEMA intends to deploy the new software in



May. VOADs, disaster interfaith organizations, food banks and food rescue organizations, United Ways, volunteer management agencies and centers, Seventh Day Adventist state leaders, and Red Cross and Salvation Army divisions will all have a stake and interest in establishing the use and coordination of Aidmatrix.

- **NYC OEM Hosts Roosevelt Tram Field Exercise**

On November 9, the NYC Office of Emergency Management (OEM), the NYC Police Department (NYPD), the NYC Fire Department (FDNY), and the Roosevelt Island Operating Corporation (RIOC) conducted a multi-agency field exercise on the Roosevelt Island Tram. The exercise tested the City's ability to respond to an emergency situation on the tram. They staged different scenarios that could strand the tram: one in which the main motor fails and the backup is used; and two where both motors fail, requiring workers to use a diesel generator to get the cars back to base, or worst case use a third generator to send out a rescue cage. At the debriefing after the exercise, emergency responders said they found no glaring problems.

On November 1, the NYC Office of Emergency Management (OEM) conducted a series of preparedness drills to gauge the city's ability to respond to a waterway emergency around the Staten Island Ferry. The Fire Department (FDNY), as well as the NYPD and the Coast Guard, conducted several exercises at the Whitehall Ferry Terminal in Manhattan and the St. George Terminal and Stapleton Anchorage on Staten Island. Streets in those areas were closed down and there were plenty of emergency vehicles on hand. Smoke was also simulated to make the drill more realistic.

- **Weather Outlook for this Winter Season**

Meteorologists at the National Oceanic and Atmospheric Administration's (NOAA) Climate Prediction Center expect warmer-than-average temperatures across parts of the West,



Southwest, Plains states, Midwest, parts of the Northeast and northern mid-Atlantic region, as well as most of Alaska for the December 2006 through February 2007 season. Near-average temperatures are favored for parts of the Southeast, while below-average temperatures are anticipated for Hawaii. Maine, the southern mid-Atlantic region, the Tennessee Valley, much of Texas and California, and the intermountain West have equal chances of warmer, cooler, and near-normal temperatures this winter.

- **In Flu Outbreak Scenario, Americans Willing to Make Changes**

A national survey conducted by the Harvard School of Public Health (HSPH) Project on the Public and Biological Security, presented on October 27 in Washington, DC at the Institute of Medicine workshop, "Modeling Community Containment for Pandemic Influenza", finds that if faced with a serious outbreak of Pandemic Flu, a large majority of Americans would be willing to make major changes in their lives and cooperate with public health officials' recommendations. It also found that many people would face critical work-related problems. This survey was conducted to help public health officials in planning for a possible outbreak of Pandemic Flu, and is the first report to attempt to tap the public's intentions when faced with the specific circumstances of an outbreak.

- **New Research into Evolution of Flu Virus**

The National Institutes of Health (NIH) announced that researchers are reporting results of a study that substantially alters the existing understanding of how the influenza virus evolves. This could have important implications for monitoring changes to the virus and predicting which strains should be used for flu vaccine. The study, published in the online journal Biology Direct on October 26, reveals a picture of flu evolution that was different from the prevailing conception of how the virus changes and that "the common view of the evolution of influenza virus as a rapid, positive selection-driven process is, at best, incomplete." NIH is a component of the US Department of Health and Human Services.

- **New Way to Keep Public Aware of Low Flu Strain**

Because the LPAI H5N1 detections are common and pose no threat to human health, the US Departments of Agriculture and Interior (USDA and DOI) are transitioning to a new method of notifying the public. In an effort to maintain transparency, USDA and DOI will post all suspected LPAI H5N1 detections on the Internet. Low pathogenic strains of avian influenza occur naturally in wild birds and cause only minor sickness or no noticeable signs of disease in birds, and are very different from the more severe highly pathogenic H5N1 circulating in Asia, Europe and Africa, which spread rapidly and are often fatal to chickens and turkeys. (In the event of a presumptive H5N1 test result involving a large number of sick or dead birds, or circumstances that suggest the possibility of a highly pathogenic virus, USDA and DOI will issue a news release to notify the public.)

- **Technology Outpaces Pandemic Preparations**

Lack of technology is not the problem when it comes to planning for a Pandemic Flu or other serious disease outbreak, speakers at the ESRI Health Geographic Information Systems (GIS) conference said last week. Instead, they cited a failure to plan across organizational boundaries and anticipate what resources will be necessary when disease suddenly strikes. "Right now, technology is ahead of pandemic influenza planning," said Dave Gruber, senior assistant commissioner of NJ Health Department's Division of Health Infrastructure, Preparedness and Response. He is using GIS to stay abreast of the public health picture, tracking, for instance, the availability of hospital beds and emergency department closings. Philippe Veltsos, from the World Health Organization's IT department, gathers disease data from 193 member countries in many formats and languages. GIS can be a tool for standardizing and replicating such data.

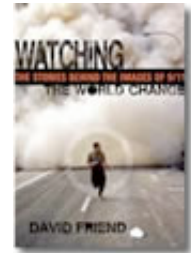
