The American Red Cross (ARC) has awarded a supplemental \$1.75 million from its Liberty Disaster Relief Fund to enhance NYDIS' 2007 coordination of services and support for 9/11 victims and injured recovery workers. This expanded grant brings the total award for 2007 recovery programs to \$2.3 million; and continues the availability of cash assistance to WTC recovery workers through the NYC 9/11 Unmet Needs Roundtable. It will also increase NYDIS' capacity to coordinate services for injured WTC recovery workers and provide seven sub-grants of up to \$55,000 for case management providers. The grant also provides for opening a Coordinated Assistance Network (CAN) profile to track service coordination for injured recovery workers.

#### ■ NYDIS & NYCOSH Publicize Worker Comp Deadline

NYDIS is joining the NY Committee for Occupational Safety and Health (NYCOSH) in collaboration with the NYS AFL-CIO, WTC Medical Monitoring Program, the Laborers' Health and Safety Trust Fund, the Business and Labor Coalition of New York, workers' compensation law firms, the UCC-National Disaster Ministries, and Wall Street Rising, is mounting a media campaign to inform workers throughout the country about the necessity of registering for workers' compensation. Joel Shufro, NYCOSH Executive Director, said, "We know that tens of thousands of people are at risk of becoming ill as a result of their exposure toxic air and to psychological trauma while



doing rescue, recovery or cleanup work after 9/11. We want to ensure that every one of them registers with the Workers' Compensation Board before the August 14, 2007, deadline. And if they don't know about the program, they won't register, it's that simple."

#### ■ The Freedom Tower's First Column Raised At Last

"Today the steel rises, the Freedom Tower rises from



the ashes of Sept. 11, and the people of NY and the people of America can be proud," Gov. George Pataki said on December 19, when a massive crane lifted the first column. Painted with an American flag and the words "Freedom Tower", the 31-foot-high column was set over steel bars on the southern edge of the Tower's base. The second column, also raised, bears the signatures of steelworkers and politicians from VA, where it spent time at a steel company before being shipped to NY. A third column, covered with signatures of New Yorkers and 9/11 victims' relatives, as well as pictures of some firefighters killed in the attack, is also being installed. "Rising from the heart of the WTC site, the Freedom Tower will symbolize the spirit of our city and our nation: inspiring, soaring and undefeated," Mayor Bloomberg said.

### ■ DOHMH Urges Completion of WTC Health Survey

On December 14, 2006, the NYC Health Department





(DOHMH) announced that in the previous three weeks, more than 13,000 enrollees in the WTC Health Registry completed the follow-up survey about their physical and mental health after 9/11. The agency urges all remaining enrollees to complete the re-survey as this is the first opportunity for enrollees to inform the Registry about their physical and mental health since 2004. Data collection will continue for the next several months, and findings will be released to the public. Established in 2003, the Registry monitors the symptoms and health conditions of many different groups affected by 9/11, including residents, rescue and recovery workers, office workers, people on the streets nearby, students and teachers in the area. The results should help health experts recognize and treat conditions potentially associated with exposure to 9/11 and its aftermath.

### ■ **Treatment Funds for 9/11 Workers Running Out**

The roughly \$40 million set aside by the federal government to treat rescue workers and volunteers who became ill after helping with the 9/11 cleanup and recovery will run out in months, physicians and federal officials said on December 18, 2006. Members of Congress from NY and NJ secured \$75 million a year ago to pay for health care expenses for about 32,000 workers who reported ailments after working at Ground Zero. Officials at the two major monitoring and treatment programs, Mount Sinai Medical Center and the Fire Department, said that at the current spending rate, the treatment money would run out by spring or summer and unless more financing was provided, they would be forced to notify thousands of patients that their treatment could soon end. Senator Clinton said, "I am not going to say where the money should come from, I'm merely saying that this should be a national priority. It is not just a NY priority."

- **NY Legislators Caucus to Address 9/11 Health Needs**

Senator Hilary Clinton, and Reps. Carolyn Maloney and Vito Fossella held a news conference to discuss the progress of the federal response to the health impacts of the 9/11 attacks. They urged the Administration to include comprehensive funding for 9/11 health treatment and monitoring in the President's budget proposal for next year and noted that although the very first federal funding for 9/11 health treatment was released in October, treatment programs currently funded may have to shut their doors as early as next summer unless they receive another round of federal support. The elected officials also urged the Department of Health and Human Services (HHS) to finally release a concrete plan to provide medical monitoring for everyone exposed to Ground Zero toxins and treatment for anyone who is sick. Senator Clinton said, "This funding is absolutely fundamental to our ongoing efforts to help those who gave so much on 9/11 and in the days after."

### ■ President Declares NYS Floods a Federal Disaster

On December 12, 2006, FEMA Director David Paulison announced that federal disaster aid has been made available for NY to supplement state and local recovery efforts in the area struck by severe storms and flooding during the period of November 16-17, 2006. He said federal funding is available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storms and flooding in the counties of Broome, Chenango, Delaware, Hamilton, Herkimer, Montgomery, Otsego, and Tioga. Federal funding is also available on a cost-sharing basis for hazard mitigation measures statewide. Director Paulison named Marianne C. Jackson the Federal Coordinating Officer for federal recovery operations in the affected area.

### ■ Upstate NY's Second Disaster with November Floods

In the midst of the holiday season, flood damage is still burdening hundreds of people in Broome County, NY. The water inundated hundreds of homes in June, and again in November. "The number-one need is furnaces," said Greg Jenkins, case management coordinator for the Broome Area Networking in Disaster (BAND), which is comprised of faith-based and community-based groups that are addressing unmet needs and helping people plan their long-term recovery. BAND is attempting to offer both financial assistance and help installing new furnaces, but the group needs more monetary donations and more volunteers. Jenkins estimates BAND will provide services for a minimum of 600 people on a long-term basis. The county had 4,800 registrations for Federal Emergency Management Agency (FEMA) assistance. While some people were hit by repeat flooding, both in June and November, others were hit for the first time in November.

### ■ Bill for New Bioterror Agency on President's Desk

Lawmakers approved legislation December 9, 2006, creating a Health and Human Services agency aimed at the prevention of bioterrorism, in a move that continues to delegate to HHS more responsibility in preparing for and responding to a potential biological attack. The Pandemic and All-Hazards Preparedness Act (S. 3678), which now awaits President Bush's signature, would authorize more than \$5 billion for biomedical research projects and would allow funds for vaccine research and development. The measure would clarify that the HHS Secretary would assume the lead role in the event of a bioterrorist attack or disease outbreak, and essentially would relegate the Homeland



Security Department (DHS) to a supporting role. HHS Secretary Mike Leavitt said the legislation "supports our efforts to improve coordination of preparedness and response programs across the department."

### ■ **New Survey Assesses First Responder Communications**

The Department of Homeland Security (DHS) announced the results of the National Interoperability Baseline Survey of first responders and law enforcement that assesses progress in achieving interoperable communications. It was issued to 22,400 randomly selected law enforcement, fire response, and emergency medical services (EMS) agencies. "The survey reinforces the fact that interoperability is achievable," said Secretary Michael Chertoff. "The willingness of emergency response leaders and local officials to make this issue their priority is what will continue to drive progress on one of 9/11's most important lessons." Survey findings will help emergency response leaders and policy makers make informed decisions about strategies for improving interoperability.

### ■ **"Ready or Not?" New Report Gives NY 7 Out of 10**

The Trust for America's Health (TFAH) released the fourth annual "Ready or Not? Protecting the Public's Health from Disease, Disasters, and Bioterrorism" report which found that the nation's public health system, the first line of defense against pandemic flu, a bioterror attack or other widespread health emergency, remains unprepared to protect the American public. The fifty states, and DC, were evaluated based on ten key indicators to assess health emergency preparedness capabilities. Oklahoma scored the highest with 10 out of 10. Only 15 states are rated at the highest preparedness level to provide emergency vaccines, antidotes, and medical supplies from the Strategic National Stockpile. New York was rated 7 out of 10. The report also offers a series of recommendations to help improve preparedness.

Mr. Balboni will have the title of deputy secretary for public safety security, which was described in a news release issued by the Spitzer transition team as the incoming administration's senior security and law enforcement official.

### ■ Ground Zero Construction Means Wall Street Disarray

The bankers, traders and residents of Lower Manhattan are about to find out what it's like to be in the vortex of the most concentrated construction zone in New York City's history. As many as 9,000 trucks a month will rumble through the district, hauling concrete, glass, and metal. Most of the supplies will be headed over the next five years for Ground Zero, that will be home to the 1,776-foot Freedom Tower, five adjacent skyscrapers, a transportation center and the memorial to the victims of 9/11. About 50 Lower Manhattan projects, costing \$20 billion, are planned or under way, including the Ground Zero construction, a new headquarters for Goldman Sachs Group Inc., and new underground water pipes, subway stations, parks and residential buildings. Charles Maikish who heads the Lower Manhattan Construction Command Center said, "The Trade Center site itself is the epicenter."

### ■ Op-Ed Suggests \$1.5 Billion for 9/11 Injured

Since 9/11 the flood of litigation continues unabated in federal court in Manhattan: 6,000 people are suing NYC, the Port Authority and more than 100 private contractors for negligence in exposing workers to toxic dust and fumes. Thousands of additional claims are expected in the next few months. Approximately 40,000 recovery workers, as well as residents of Lower Manhattan and others, are all potential litigants. Some will probably eventually suffer the same ailments that have led to the current lawsuits. The federal judge presiding over the lawsuits has urged settlement, warning that continuing the litigation is inefficient, expensive and risky to all parties. The mere existence of thousands of lawsuits fuels uncertainty and delays the payment of compensation to eligible victims. In an OP-ED column in the New York Times, Kenneth Feinberg, contends that there is \$1.5 billion available to settle the pending lawsuits, more than sufficient to pay all eligible claims.

## ■ NY Lawmaker Proposes Screening of Airport Workers

More of the nation's airport personnel are undergoing background checks, and some lawmakers want all of the nearly 1 million workers to be screened when they arrive on the job each day, USA Today reports. "This is the weakest link in aviation," said NY Representative Nita Lowey, a senior member of the House Homeland Security Committee, who has proposed a bill that would require airport employees to be screened for weapons. Most airport workers must pass a background check when they're hired, which then allows them to pass unchecked into secure areas.

## ■ OSHA's Lessons Learned from Katrina and 9/11

In an interview with Occupational Hazards, Ed Foulke, the US Department of Labor's Occupational Safety and Health Administration (OSHA) Administrator, says he is confident that after the lessons learned from 9/11 and Katrina, OSHA has a solid system in place. For instance, OSHA has trained its inspectors in emergency response and supervisors from OSHA area offices along the Gulf Coast region have been trained to work with FEMA on how to coordinate training and response, and the agency has prepared materials for the aftermath of another disaster. When asked why OSHA exempted enforcement during the hurricane disasters, Foulke explains that FEMA made it OSHA's mission to provide technical assistance only. But Foulke says the need for technical assistance was so much greater and it probably allowed the agency to get to more areas if it wouldn't have been operating under that mode.

## ■ Emergency Hospital Disaster Plan Developed

US medical researchers say hospitals planning for a surge of disaster victims should begin with a strategy to empty beds of relatively healthy patients, reports United Press International (UPI) on December 8, 2006. The researchers, led by Dr. Gabor Kelen, director of emergency medicine at Johns Hopkins Hospital in Baltimore, say data suggest such a strategy could safely empty 70 percent of a hospital's inpatient population within 72 hours. Health care officials fear few US hospitals could deal with the extraordinarily large numbers of casualties that can be produced by a natural disaster such as Hurricane Katrina, epidemics or a terrorist attack like 9/11.

## ■ Katrina Inspires Pet Evacuation Law in NJ

Learning from Katrina, New Jersey lawmakers passed a law requiring each of the state's 21 counties to make preparedness plans for pets during an evacuation. New Jersey is one of nine states that passed laws dealing with pet evacuations. "It looks like NJ's law is one of the strongest in the country, as it prescribes very specific measures to help animals in disasters," said Michael Markarian, a vice president with The Humane Society of the US (HSUS).

### ● OEM Reviews Response After October Plane Crash

On October 11, 2006, Yankees pitcher Cory Lidle's plane crashed into an Upper East Side building in Manhattan. NYC OEM Watch Command and responders picked up the incident over the FDNY radio and immediately dispatched a team to the site. The OEM command bus arrived and established an interagency command post. OEM coordinated a massive response force from the fire and police departments,



the Department of Buildings (DOB), the medical examiner's office, ConEd, the National Transportation Safety Board (NTSB), the Federal Aviation Association, the Mayor's Community Assistance Unit, and the American Red Cross in Greater New York (ARC GNY), using the same emergency protocol it applies to all fires, explosions, and partial building collapses it encounters. OEM responder, Fred Reich, cites "lots of agency training," as the secret to the success of this response.

- **Best of 2006 Award for NYC OEM's New Office Building**

NYC OEM received Construction Magazine's Award of Merit for Adaptive Reuse for their new office building. It is a converted 1954 building which formerly served as the NY home of the American Red Cross, and will become the first "green" agency headquarters in NYC. Mayor Bloomberg, in his weekly radio address on 1010 WINS News Radio on December 10, 2006, said, "Located in Downtown Brooklyn, this is OEM's first permanent home since 9/11, when its former headquarters at 7 WTC was destroyed. It contains four facilities essential to OEM's mission - all designed with back-up systems and emergency generators that will permit them to operate in the event of a power outage. The new Emergency Operations Center (EOC) [where NYDIS has a designated seat], will be the nerve center for managing multi-agency responses to large-scale events or emergencies. The new headquarters also houses an enhanced "Watch Command", where emergency services personnel will conduct ongoing, round-the-clock video and audio monitoring of events affecting our city, and communicate with police, firefighters, and other 'first responders' as well as with State and Federal authorities."

On December 27, 2006, the Egyptian Ministry of Health and Population informed the World Health Organization (WHO) of three new human cases of Avian Flu A(H5N1). All three cases belong to one extended family in Gharbiyah province, close to Cairo. While being transferred and cared for at the country's designated Avian Flu hospital, all three died. The cases reportedly had contact with sick poultry (ducks). The Egyptian Ministry is conducting further investigations and has initiated public health measures. The other family members are healthy and under close observation.

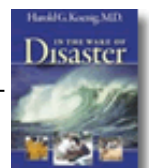
